# 7.4. Budget Update FY19

Due to ESSA (Every Student Succeeds Act), there have been required changes from the Federal Government in how schools code budgets. In the past few months, thousands of codes have been updated in order to create our budget. DC West's financial system software company as well as ESU 3 have been assisting in this process. Superintendent Poloncic provided information on the budget planning for the 2010 fiscal year that is currently in progress. In August, there will be a categorical budget available to the Board.

# 7.5. Approve Purchase of Lobby Flooring by Main Gym

Due to wear and tear on the lobby tile outside the main gym this summer from construction and the boiler relocation project, in addition to a needed update, the Board was asked to approve the purchase of new flooring for this area. Bids were received from Baldwin's Flooring (\$26,500) and Commercial Interior Solutions (\$37,736) for ultra-wear carpet as a replacement for the current tile flooring.

The administration recommended accepting the quote from Baldwin's Flooring in the amount of \$26,500 with the addition of a second proposal to carpet the ramp from the high school for an additional \$885 for a total bid of \$27,385. This expense will be covered within the summer 2018 in-house maintenance projects budget.
