VII.D. Recommended Staff Additions for 2016-17

After reviewing district enrollment, schedules, current teachers' class loads as well as class sizes, the high school administration and Superintendent Poloncic recommended the addition of the following to current staffing:

- * Increase of .65 FTE Physical education (to be added to current .35 FTE that is shared with middle school).
- * Add .25 to .5 FTE of High School Math and Science.
- * Increase .35 FTE Elementary Music (to the already contracted .15 FTE, creating a .5FTE elementary music position).

In total, this is an addition of 1.25 - 1.5 FTE to the current certificated staff at DC West.
